From Ken Wiley:* We would like to seek your input on an opportunity regarding our sequencing efforts for eMERGE. Originally, it was proposed that sequencing efforts would continue till the end of the award period, which is May 2019. However, in order to allow investigators the ability to analyze their data while still in the award period of their grants, we are exploring the possibility of having our sequencing efforts completed during the second quarter of 2018. While allowing a few months for cleaning of the data, this will leave a portion, if not all, of the final year of eMERGE's funding period available for investigators to analyze their data. As one can imagine, several adjustments will have to be made to facilitate this transition. One such adjustment includes increasing sample submissions from investigator sites to their respective CSGs. To help address this, the CC has put together a table ([emergesequencingflow.xlsx](#)) that includes adjustments to each sites' projected sample submission. I would like to ask that each investigator review their site's revised sample submission numbers, which is 200 per site per shipment unless the number is in **bold (which indicates a deviation from the 200, higher or lower, or that the submission requires samples before the site has indicated they are available), and dates for anticipated sample delivery to their respective CSG. Also, please review your projected recruitment goals (the numbers in **red**) and determine if the deadlines, recruitment goals, as well as sample numbers for submission, are achievable for your site. Finally, we have also scheduled a morning session (Tuesday, January 26th, 8:00-8:25 AM) during our upcoming steering committee meeting to further discuss this opportunity and receive your feedback.
